2307 hours: "Tell dumb ass he has visitors!!!!!"

Deputy Bacon observed the phone number come back to said and address using law enforcement resources. Deputy Bacon further observed had called the Volusia Sheriff's Office non-emergency number on November 3rd using the same number and identified himself as
advised the harassing messages being sent to her have caused extreme emotional distress because of sactions. Deputy Bacon was informed had asked to stop messaging her and leave her alone but this request was ignored. Deputy Bacon attempted to scroll up in the text messages to locate this message, but due to the extensive amount of texts from in the last few hours alone, was unable to locate the message. While on scene, Deputy Bacon observed to be fearful of anyone arriving to the residence, her voice to be shaky, and observed her to be holding back tears during questioning. Sadvised has a large collection of firearms of many different types. Completed a sworn written statement which advised she wished to pursue criminal charges. Simple invoked Marsy's law and was provided with a Volusia Sheriff's Office victims rights and remedies pamphlet with the case number attached, which she signed for.
Deputy Bacon then spoke with who confirmed his fear of coming to the above stated residence and killing him. advised knows shows him all the text messages he sends and therefore would know he would see the threats is making. advised he was so fearful for him and safety, he has chosen to take out of town to a hotel for safety. Further advised his mother was receiving text messages stating how she would want to protect her child, but too late. completed a sworn written statement which advised he wished to pursue criminal charges. In invoked Marsy's law and was provided a Voluisa Sheriff's Office victims rights and remedies pamphlet.
Deputy Bacon collected copies of the above stated text messages and later uploaded them to the Digital Crime Scene Database.
Based on the above stated investigation, Deputy Bacon determined probable cause exists to charge and arrest for aggravated stalking (domestic violence) for the hundreds of messages of threats to and clearly unwanted contact. Deputy Bacon Further determined probable cause exists to charge and arrest for written threats to kill for stating he was going to kill via text message. Due to Deputy Bacon being unable to locate Deputy Bacon completed a 707 pass along and placed it into the District 4 pass along folder.
