Deputies were able to make telephone contact with to inquire what could be done to deescalate the situation and for a peaceful resolution. explained he is stressed over not being able to work, and fighting with the DMV over getting his license fixed. came out of the residence multiple times, and quickly retreated back into the home.
Conversation was held and maintained with exit the residence. exited the residence with a phone in his left hand and a cup in his right hand. walked towards deputies with his pants pocket inside out and hands in the air. was approached by deputies and explained the situation over again. made several statements "that if I'm not able to work I don't have a reason to live". was placed in protective custody at 1643 hours without incident.
was transported to Stewart Marchman in Daytona for a mental health evaluation. Upon arrival at Stewart Marchman made several statements explaining how he was scared when he fired his first round inside of the house. Went on to say he fired 10 rounds into his television.
