(O1), who was not on scene, has not been able to help him either.
Central Communications advised had a gun to his head and said he could not talk for too long.  Deputies responded to the residence and were able to contact via telephone. Deputy Gourley was speaking with over the phone regarding his suicidal thoughts. referenced having a "45" which is a common caliber for handguns. Utilizing descalation techniques, Deputy Gourley was able to have exit the home. Deputies took into protective custody under the Baker Act.
