Deputies were given permission to review the firearms in the house and determined they were safely secured in a gun safe located in the parent's bedroom. While observing the firearms, Deputies located a black Glock holstered in a black plastic holster, matching the description of the firearm the victim identified.

There was not enough evidence to support an arrest with a firearm, but due to the potential violence and the person poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in their custody or control the RPO is completed.

The firearm was not collected on scene.
