DeLand in reference to medical assist for the fire department. Upon arrival, Deputy Blum made
contact with (R1), who advised the following: received a text message
from her nephew, whom resides in another county, about being suicidal. explained
messaged his cousin and explained he was depressed and wanted to end his life by shooting
himself. The cousin ultimately became concerned at called on his cell phone.
up the phone and began to cry about being suicidal. The cousin proceeded to send a text
message to check on explained she proceeded to call girlfriend,
(O1), about the situation. Deputies made contact with who explained she
arrived at the aforementioned residence and discovered holding his firearm and a shell
casing on the ground near him. Deputies observed the shell casing and a bullet hole in the wall
potentially matching the casing. Deputies attempted to ask about the incident, but he could
not answer any questions due to him being highly intoxicated at the time.
Due to the circumstances and evidence, Deputy Childs placed in protective custody under a
baker act and transported him to Halifax Health due to him being highly intoxicated.
Deputy Bender completed and RPO due to the involvement of firearm.
