On 04/08/2022 at approximately 2208 hours, Deputy Rogers responded to ██████████ ██████████, Deltona in reference to a suicidal person. Upon arrival, Deputy Rogers made contact with the reporting party ██████████ (R1), who advised the following:

██████████ advised his wife ██████████ (V1) had made multiple suicidal statements throughout the day. ██████████ told ██████████ she would consume a numerous amount of her prescribed medication pills. ██████████ had been argumentative and made threats to harm herself. ██████████ was searching through her residence to find a .22 pistol that was gifted. ██████████ stated she was going to shoot herself. ██████████ completed a sworn written statement detailing the incident.

Deputy Rogers observed ██████████ to be pacing back and forth inside of the residence with no clothing on. ██████████ opened the front given multiple verbal commands to come outside. ██████████ refused to abide by the commands she was given, shutting the door, and can be seen walking to the back of the residence. Deputy Rogers observed no injuries on her body.

Based on the statements from ██████████ and observations of ██████████ Deputy Rogers found reason to believe ██████████ is unable to determine for herself and without care or treatment, ██████████ is likely to suffer from neglect or refuse to care for herself; such neglect or refusal poses a real and present threat of substantial harm to her well-being. There is a substantial likelihood that without care or treatment, ██████████ will cause serious bodily harm to herself or others.

Deputy Rogers secured ██████████ and informed her she was not under arrest, but instead would be taken to a receiving facility for involuntary examination. Deputy Rogers transported ██████████ to Stewart Marchman Act (SMA) without incident.

There is no additional information at this time.
