A tag was given of which did not come back as a good tag. While responding to the area, Deputy Eveler observed a green Subaru displaying Florida registration of the vehicle was traveling south on Providence Blvd at E Chapel Drive. Deputy Eveler observed the vehicle until it pulled into the parking lot at 1229 Providence Blvd, Deltona. Deputy Eveler conducted a traffic stop on the vehicle.
Deputy Eveler ordered the driver to show his hands and the driver complied. Deputy Eveler then came in contact with (D1) who was the sole occupant of the vehicle. was asked if he had any firearms which he stated he had one between the driver's seat and center console. was secured and escorted out of the vehicle for safety. Deputy Eveler advised of his Miranda Warning which he acknowledged and waived electing to speak with Deputies. advised he was traveling on Howland Blvd when an 18 wheeler almost ran him off the road. further stated he did not display his firearm despite the fact the caller knew that was armed and was able to describe it. denied picking up or brandishing the firearm at all. Sergeant Patterson responded to the scene. Sergeant Patterson began speaking with who stated he did in fact display his weapon inside the vehicle, pulling it from its holster and brandishing it while he was driving.
s firearm was secured. The firearm was a Phoenix arms .22 pistol with a serial number of #4547769. The weapon was loaded with 5 rounds in the magazine and 1 in the chamber.
Deputy Marty responded to the scene and made contact with (V1). advised he was traveling on Howland Blvd in the area of Graves Avenue, Deltona, Florida, when a green Subaru cut him off. The two vehicles continued to travel down the road the Subaru was in front of the 18 wheeler. then observed the driver of the Subaru waving a silver handgun out the window and pointing it back at him. The driver then cocked the gun as he continued driving. described the driver as a black male, gray hair, black shirt, gray shorts, with a silver handgun. completed a sworn written statement in which he advised he wanted to press charges and that he was in fear. invoked Marsy's Law electing to keep his information private.
