Deputy Hunter made telephone contact with the anonymous person who later identified herself as (R1). Explained her friend, (O1), called her and stated (V1) was texting her and making suicidal statements.
Deputy Hunter then made contact with via telephone. Stated she and were previously in a relationship and have a minor child in common. advised the relationship ended approximately two years ago. She continued by stating has not been able to accept the fact their relationship was over. She also stated has an ongoing issue with the use of illicit drugs and has previously overdosed. Stated made comments earlier in the morning to the possibility of , "committing suicide by cop." presented Deputy Hunter with a large amount of text messages and telephone calls from displayed very erratic and out of control behavior throughout the text messages. provided a sworn written statement. She also provided screen shot photographs of text messages sent to her by
Sgt. Cheek was made aware of the call details and subsequently responded to the scene, at which time a perimeter was established around the residence. also arrived on scene and allowed deputies to make contact with using her cellular phone. It was later determined had exited the rear of the residence prior to deputies arriving on scene and fled the area. Deputy Bernard spoke to several times using several scellular phone, however would only speak for a brief period and then disconnect. Deputy Bernard later convinced to give his location to allow deputies to make contact with him and assure he was safe. later agreed and stated he was at 27 Charles R Beall Blvd.
