On 06-24-2023, at approximately 1043 hours, Deputy Forster responded to Pierson in reference to a subject making suicidal statements. (R-1) stated an unknowsubject later identified as had called him and stated, "You can tow my car after I shoot myself". Upon arrival, Deputy Forster made contact with (V1) who explained the following:
Deputy Forster approached the residence and heard an argument in the back yard. Deputy Forster walked to the side of the house and observed (O1), and (O2) in an argument. Saw Deputy Forster and stated he wanted Deputy Forster to shoot him in the chest. It should be noted, Deputy Forster observed a black and brown shotgun held by side, however it was never pointed at deputies. Deputies were able to de-escalate and get behind cover with to begin a dialogue with While deputies and moved behind cover, and retreated in the residence. Deputies spoke to who explained has father is getting a divorce with after thirty years of marriage. Explained has been heavily drinking all week and is extremely intoxicated. advised has been making multiple statements on 06-24-2023 about ending his life.
Deputies observed walking in and out of his residence aggressively with the shotgun in his hands. Later gained possession of the shotgun in the house and brought it to deputies and advised has no access to any other firearms in the residence. The refused to go with deputies and explained he would mediate the conversation for the Negotiators later arrived on scene and began dialogue with the via cellphone. Negotiators were able to convince and to later exit the residence, where the was secured.
Based on the totality of circumstances, Deputy Forster placed into protective custody under the baker act due to the substantial likelihood that without care or treatment cause serious bodily harm to himself or others.
Deputy Forster later completed a Risk Protection Order on and left a receipt of the RPO to at the aforementioned residence.
