On 07/28/2023, at approximately 1501 hours, Deputy Autrey and Deputy Galarza were dispatched to ██████████ in reference to a suicidal person complaint.

Upon arrival, Deputy Autrey made contact with ██████████ (R1), who stated the following :

██████████ (V1), had made multiple statements over the past year that he was going to kill himself, because his wife was on end-of-life care and was not expected to live much longer. ██████████ stated to ██████████ he was going to put a bullet in his head because he did not want to live without his wife.

Deputy Autrey made contact with ██████████ who stated that he was very emotional because his wife was getting ready to pass away. ██████████ admitted to stating that he wanted to kill himself. ██████████ informed Deputy Autrey that there was a pistol in his drawer upstairs in his room but that was the only firearm that he owned. Deputy Autrey made contact with ██████████ (O1), who advised his father ██████████ was very emotional and confirmed ██████████ made statements about killing himself.

██████████ filled out a sworn written statement and agreed to take possession of his father ██████████ firearm. It shall be noted, ██████████ said no firearm was located in the drawer where ██████████ stated it would be but all that was found was a BB gun.

Based on the above information, statements made by ██████████, witnesses present, ██████████ was placed in custody under a baker act and later transported to Halifax Hospital for further evaluation without incident.



It shall be noted, an RPO was completed.
