On 08/04/2023 at approximately 2041 hours an employee of Dixies Gentlemen's Club called the non-emergency central dispatch line advising there was a physical altercation between employees of Dixies and a patron. The employee advised the patron exited the establishment threatening to return with a firearm. The reporting party advised the patron was in the rear of the parking lot in a red truck facing the woods.
At approximately 2050 hours Deputy Fortier arrived on scene and located the above-mentioned vehicle. Deputy Fortier observed a male subject standing next to the driver's side door of the vehicle wearing a brown shirt, blue jeans, and boots. It should be noted the male subject had blood covering his face and shirt and pants.
The male subject was identified as When was asked why he was covered in blood he stated he had bitten his lip. was asked if he wanted medical attention, which he declined.
While talking to the was asked if he had a firearm on his person or in his vehicle.  dmitted to having a shotgun inside his vehicle and allowed deputies to inspect it.
Inside the vehicle deputies located a black 12-gauge shotgun bearing serial number with several rounds of ammunition, which were placed with VSO Evidence.
Deputies contacted who stated was asked to leave the property after becoming too aggressive with the female workers. walked out of the front door of the establishment, then ran back at the door hitting in the face with his fist. stated he defended himself by hitting after which he was able to lock the front door of the business, preventing provided a written sworn statement.
Deputies contacted who witnessed the altercation. reiterated everything stated. added commented he "will have people set the place off". continued by stating he heard state he was going to "shoot this place up". provided a written sworn statement.
