On the date of this report, spoke to about wanting a divorce.  became upset, went to the master bedroom nightstand and picked up a handgun. He explained to be was going to shoot himself and it was her fault. He then left the residence, in an unknown direction in a blue Jaguar, bearing Florida tag eft the residence she and shared, and went to a friend's home, to be safe from and contact law enforcement as unaware of any other firearms had in his possession and was unaware of any place other than the beach he might travel to. She noted was wearing a long sleeve blue t-shirt with khaki shorts. completed and signed a sworn written affidavit attesting to statements.
Deputy Naylor contacted Volusia Sheriff's Office teletype to have entered into FCIC/NCIC as missing. He was entered as missing and suicidal by Operator Stone #9400.
and the blue Jaguar were located at compliant and was taken into protective custody for a Baker Act. The firearm, a loaded black in color (serial number), advised took was located within the Jaguar, in the pouch behind the passenger seat. When deputies spoke with advised it was possible he made statements to his wife which might cause her concern for his safety. He noted the two had been in an argument, and he appeared downtrodden to deputies on scene. The firearm was seized for the RPO. Was taken to Halifax Hospital for the Baker Act without incident, after being told an RPO would be completed was contacted in reference to her husband being taken into protective custody. She was made aware of the Jaguar which remained on scene, as well as the firearm. Advised she was not going to pick up the vehicle, and it was towed by Arrow towing.
A criminal history was completed for which showed one previous charge for assault caused bodily injury. This charged showed a disposition of held as of 05/22/1998.
