On this date and time, [REDACTED] and [REDACTED] were arguing at the [REDACTED] home. [REDACTED] drove to the [REDACTED] address and picked up his daughter for the day. While on scene [REDACTED] began making suicidal statements and punched a window cutting her hand. [REDACTED] and [REDACTED] drove to [REDACTED] which is his parents' home.

Deputy Greene met with [REDACTED] and observed text messages on his phone. The messages said "when something happens to me and it will, it's going to be bad on you and you will regret it for the rest of your life. I have a gun and it's going to happen." [REDACTED] stated [REDACTED] had access to a Ruger .22 caliber rifle and she was firearm proficient.

Sergeant Wallis and several deputies responded to the [REDACTED] address and determined [REDACTED] was not on scene. Sergeant Wallis had dispatch initiate a ping on [REDACTED]'s cell phone, with the carrier T-Mobile. As deputies were on scene, Deputy Campbell located [REDACTED] driving her pick up truck on [REDACTED]. Deputy Campbell and K-9 Deputy Whitson conducted a traffic stop on [REDACTED]'s truck and she was taken into custody without incident.

[REDACTED] completed a sworn written statement indicating the statements [REDACTED] made. Deputy Greene completed an involuntary examination Baker Act form and [REDACTED] was transported to Halifax Medical Center.

Deputy Campbell assisted in completing the Risk Protection Order paperwork.

Deputy Greene obtained a photo of the text messages from [REDACTED]'s cell phone.

[REDACTED] responded to [REDACTED] and took possession of the family dog and all firearms.

Deputy Greene presented [REDACTED] with a business card and advised him of the case number and status.
