mentioned comments and dmitted he was the author of those comments. Detective Howard then read his constitutional rights via an agency issued advice of rights card. continued to talk and made statements about the comments were meant to be trolling and he often trolls (Attempting to incite online arguments and emotions with opposing opinions with the intent to provoke an emotional response) many people online dvised he has no intentions to harm anyone and was only making comments on the online message boards related
Detective Howard asked f he is fascinated with mass shootings and he advised he is curious to learn about them, but has no intentions to harm anyone. It advised he understood he did wrong and was apologetic to law enforcement and his mother. Detective Howard asked f he belonged to a local church as a lot of his comments referenced him targeting his church.
was then secured and transported to District 4 for completion of paperwork.
Detective Howard and Detective Smith then spoke with the family, who agreed to allow detectives to walk the residence and look inside room. No weapons or suspicious items were observed.
advised there is one pistol in the residence, which is secured in a gun box, which is locked in the garage closet advised decreased ones not have access to the firearm and he now plans to have it removed from the residence.
The entire contact at the residence was recorded on Deputy Woodin's BWC.
Upon completion of paperwork, was transported to the Volusia County Branch Jail and charged with FSS 836.10 - Written threats to kill or conduct a mass shooting.
