| (V1) had attempted to take his life with a firearm. advised once he had gotten to the house, he had taken possession of the firearm that had attempted to use as well as several others and had brought them to his house across the street for safekeeping as longer wanted them in the house. |
| Deputy Muzzy spoke with inside the residence, and she advised that she had went to check on her husband and had walked into the bedroom and witnessed him holding a pistol in his hands. It had pulled the slide back, chambering a round and was in the process of turning the firearm around to face him, in what assumed was to kill himself. When took the firearm from before he was able to fire it, asked him what he was doing and advised, "I was going to end it all." further advised that had stage 5 Parkinson's and had sustained several falls in the last few days and had been feeling like a waste of space and a burden to his family over this. |
| Deputy Muzzy spoke with about the incident; however, he was confused as to what was going on and advised nothing had happened. When Deputy Muzzy asked him about the incident with the firearm, advised that he was allowed to do as he pleased within his own home and that law enforcement had no reason to be there. When Deputy Muzzy explained that due to him attempted to hurt himself, law enforcement had to take action, advised he never pointed the gun at himself and had only pointed it away and out the window. |
| Deputy Muzzy determined without a mental health evaluation and treatment; posed a significant risk to himself. was taken into custody under the Baker Act and transported to Halifax Health in in Daytona Beach via an ambulance due to his medical concerns. |
| Deputy Muzzy additionally completed an RPO in regards to this incident due to the attempted use of the firearm. advised due to the fact that his family would have been taking all the firearms in the near future anyway, he would take possession of them and keep them at his house, away from completed and signed a sworn written statement detailing this and the fact he will have possession of the firearms. |
