On 03/01/2023 at 1852 hours Deputy Ray responded to Neighborhood Walmart (1569 Saxon Blvd. Deltona) in reference to an aggravated assault call. Upon arrival, Deputy Ray made contact with V1) who advised an unknown older white male wearing a cowboy hat and black vest pointed a firearm at his face. Stated the unknown male was currently inside Walmart. Stated the firearm was silver and had two barrel which made him believe the firearm was a Derringer. Deputy Ray had waited for other deputies to arrive.
Upon the arrival of Deputies, an outside perimeter was set and Deputies waited for the unknown male later identified by his Florida driver's license as (D1) to exit the store. Once exited Deputies detained him. Deputies asked if he had any firearms on his person to which he stated he had a firearm in his vest pocket. Deputies removed the firearm from person and walked him to Deputy Ray's patrol vehicle. The firearm on person was a 9mm Makarov pistol serial number
Deputy Ray read his warning of Constitutional Rights via his agency issued Miranda card. Stated he understood and choose to speak with Deputy Ray without a lawyer present. Post-Miranda advised the following:
He was waiting for an unknown person to back out of a handicap parking space. The unknown male was speaking about was later identified as tated backed out the parking spot and an unknown person later identified as (W1), parked into the parking spot. Stated he drive behind approached him about calling a "whore". Stated approached his vehicle saying something to him. Stated he opened his door to hear what was saying to him, because his window was broken. Stated was not minding his business and was trying to give him a lesson in manners. Stated he told to "get fucked" as was walking away from his vehicle. Stated turned around and walked back to his vehicle yelling at telling him if he wants to fight lets go he would "beat his ass". Stated he pointed his chrome .38 caliber Derringer at and stated, "you are going to have to get through this first".
