Stated to her before going outside was attempting to leave the residence in his vehicle therefore she stood by the driver side door. Stated took his firearm pistol and placed it under his chin.
was on the phone with neighbors/friends who wished not to be identified who arrived on scene to assist with the situation. Stated took the firearm from his head and placed it on the back of the truck before walking away from the residence with the male friend who arrived on scene. Stated the residence has video cameras that captured a brief moment of the incident.
showed Deputy Ray the video footage that was captured which displayed the following: was holding the firearm in his right hand behind his back. says something that can not be understood. releases the magazine, unchambers a round from inside the firearm and in a angry manner throws the firearm onto the bed of his truck. walks out of camera view. appeared to display an unpredictable behavior as to his intentions as to what he was going to do with the firearm.
emailed a copy of the video footage to Deputy Ray which was submitted into D4 evidence locker. Deputy Ray observed one .40 caliber round on the ground and an unloaded .40 caliber pistol on the bed of the truck.
Deputies made contact with at the interaction he did not wish to provide information in reference to what occurred. Based on a statement and video footage, was placed into protective custody under the Baker Act due to a substantial likelihood that without care or treatment he would cause great bodily harm to himself or others in the near future.
Deputy Ray seized the black Glock pistol serial number 1 magazine and 10 rounds of ammunition and submitted them into D4 evidence locker. Deputy Ray completed a RPO (Risk Protection Order) and submitted it to the RPO submission group. Deputy Ray transported to ACT, Daytona Beach.
