Deputies arrived quickly in the area and made contact with the wife of the suicidal person, (R1), outside of the residence. advised the following: She was unsure what triggered her husband, to begin stating he did not wish to live anymore and enter the backyard with a loaded 9 millimeter pistol. fired one shot, which believed was an attempt to harm himself, however, he missed. After the shot was fired, went inside the residence and armed himself with a knife. At this time, was able to take the firearm and hide it from At this point, emoved herself from the residence and made contact with deputies who assumed the scene. It should be noted, has been baker acted several times, with the last time being approximately one month ago.
Deputies maintained their distance and located pacing in and out of the residence, armed with a knife. After an approximate thirty minute negotiation to plead with to surrender to deputies, greed for deputies to take him into custody, which occurred without incident.
Based on the statements provided, coupled with the observations on scene, Deputy Bartzer determined without proper care or treatment was likely to suffer great bodily harm to himself. Subsequently, was placed into protective custody under the Baker Act and transported to Stewart Marchman in Daytona Beach for further evaluation.
On 05/21/2023, at approximately 1515 hours, Deputy Bartzer responded to the location of incident in order to conduct a follow up investigation. Deputy Bartzer made contact with
who advised the following: Clarified that has never been baker acted by law enforcement and has sought help voluntarily two times previously. Only has one firearm in the residence that stays in her purse. When sleeps, her purse is near her so she can feel if is trying to look through her purse. Woke up around 0400 hours to use the restroom and believed was up getting ready for work. After coming back from the restroom she did not think anything was going on and went back to bed. She believes approximately 20-30 minutes later is when she woke up to hearing one single shot. Thecked on her kids prior to going to the backyard and seeing slumped over. Pleaded for the firearm since was still holding it and was ultimately successful with retrieving it. Deputy Bartzer observed one spent 9mm shell that located in the backyard of the residence near the porch. There were no signs of any bullet strikes.
