On 05/10/2024 at approximately 1513 hours, Deputy Santiago responded to  Deltona in reference to a suicidal person. Prior to arrival Central Dispatch advised the male stated he wanted to shoot himself, however, did not have access to any weapons. Upon arrival, Deputy Santiago made contact with (V1) inside the living room of his residence, who advised the following:
advised he could not do it anymore. had just recently been released from a hospital due to a fall. stated he was in pain and his family wanted to put him in a nursing home against his wishes. stated if he had a gun, he would shoot himself to end it all.
After Speaking with Deputy Santiago determined without further evaluation and treatment, posed a significant danger to himself. Was placed under the protective custody of the Baker Act and later transported to Halifax Health Medical Center, Daytona Beach without incident.
Deputies later completed an RPO due to threatening to shoot himself with a gun.
