On 5/25/24 at approximately 0537 hours, Deputy Eveler responded to the area of [REDACTED] and [REDACTED] Osteen, Florida, for the report of a well being check. [REDACTED] (R1) and a friend called in advising that [REDACTED]'s husband, [REDACTED] (V1) had made suicidal/ homicidal statements. [REDACTED] had told family and friends he wished to kill himself and had placed a gun in his mouth. Additionally, [REDACTED] was said to have been drinking for 24 hours, was very angry, would be hostile to Law Enforcement and was armed with a 40-caliber handgun. Deputies were told [REDACTED] was looking for [REDACTED]'s friend and may have had hostile intent toward him.

Deputy Eveler went to the area of the friend's house at [REDACTED] and [REDACTED] Osteen. While in the area observed the gray Toyota [REDACTED] was suspected of driving. Deputy Eveler was able to verify the vehicle's tag as [REDACTED]. Deputy Eveler attempted to conduct a traffic stop on the vehicle at SR 415 prior to Howland Blvd. Deputy Eveler was operating a marked patrol vehicle and activated his emergency lights and sirens. The vehicle failed to stop and continued driving north without accelerating or taking any evasive maneuvers. [REDACTED] then drove a short distance before parking in his driveway at [REDACTED]. Due to [REDACTED]'s statements, the slow speed of the following and not knowing if others were within the residence who maybe in danger from [REDACTED] Deputies followed [REDACTED] to his driveway.

Deputy Eveler exited his vehicle, drawing his issued handgun and began giving commands to [REDACTED] who slowly complied. [REDACTED] was secured in handcuffs. A search of the vehicle did not reveal any firearm. Due to [REDACTED]'s statements and threats of self-harm and harm to others a Baker Act was initiated. [REDACTED] was transported to Halifax Daytona for treatment.

It was discovered that a family friend was inside the residence when she emerged after Deputies had secured [REDACTED].

An RPO will be completed for [REDACTED].




