On 07/12/24 at approximately 1356 hours, Deputy Estrada responded to [REDACTED] Deltona in reference to a suicidal person. Prior to arrival, Deputy Estrada spoke with [REDACTED] (RP) via cellphone who advised the following:

[REDACTED] and her boyfriend, [REDACTED] (V1) are going through a rough time in their relationship. [REDACTED] received a phone call from [REDACTED] on 07/12/24 at approximately 1355 hours. [REDACTED] told [REDACTED] not to bring the children home because he did not want them to see what he was going to do to himself (referring to self-harm). [REDACTED] advised [REDACTED] did not mention how he was going to carry out the action. [REDACTED] mentioned there was a shotgun in the residence where [REDACTED] was at when asked by deputies if there were firearms inside the residence. [REDACTED] said [REDACTED] did not say he was going to use the firearm.

[REDACTED] met with Deputy Rodriguez and provided a sworn written statement and she provided text messages that showed [REDACTED] stating "you are going to have to bring the children to the wake and they are going to be upset."

Deputies met with [REDACTED] and secured him. Deputy Estrada spoke with [REDACTED] [REDACTED] advised the following:

At first, [REDACTED] denied mentioning any statements of self-harm. [REDACTED] then admitted to the statements made to [REDACTED] to get her to react.

Based on the statements by both parties, Deputy Estrada determined without care or treatment, [REDACTED] would likely harm himself. Deputy Estrada placed [REDACTED] in custody under the Baker Act.

An RPO was completed.
