Once deputies arrived on scene opened a door to the house to allow deputies inside. As deputies entered the home, they saw and challenged him to comply with deputies commands.
Deputies interviewed who was hysterical but cooperative. denied ever pointing a gun at himself and denied ever threatening or attempting self-harm. stated he was taking the gun apart to clean it. stated he received the firearm from his cousin who he claims is incarcerated.
dissatisfaction in the relationship. Stated after the argument she went into the kitchen to wash dishes and heard her eight-year-old daughter scream that her father had a gun and was going to kill himself.
told deputies she witnessed her dad manipulating a gun in her parent's bedroom.
told deputies she walked into her parent's bedroom and witnessed her dad press the muzzle of the firearm into his lower jawline.
Based upon the statements provided by all parties involved, Deputy Williamson determined there was a substantial likelihood that without care or treatment he would cause serious bodily harm to himself or others. was placed under the protective custody as a Baker Act and transported to SMA Daytona Beach.
The black in color CZ75 handgun (along with 15 rounds of 9mm ammunition recovered from the scene, were submitted into district 4 evidence locker.
A Risk Protection Order was filed against voluntarily signed and surrendered his firearm to the Volusia Sheriff's Office.
Volusia County Department of Juvenile Services Director Carla Quann and DCF notified.
