Consent was given by for law enforcement to retrieve his firearm inside of the home. then escorted the deputies inside and as a result, the deputies recovered a Taurus 856 revolver (SN# from inside of the bedroom nightstand with sconsent. A FCIC/NCIC records check was conducted on the firearm which returned negative results for the firearm being related to any criminal activity. The firearm was submitted into the district four evidence locker as evidence to this incident.
Deputy Baba reviewed the footage taken by from her cellphone, inside of the residence. The footage depicted prandishing a firearm in the direction of the cell-phone and the subjects behind the phone. While was brandishing the firearm, he was yelling at everyone to get out of the house immediately. The video is one minute and two seconds long and was uploaded to Evidence.com via Axon Capture.
Based on the statements of all parties involved as well as the evidence recovered on scene, Deputy Baba determined probable cause exists for the arrest of charges: Aggravated Assault with a Deadly Weapon without Intent to Kill Using or Displaying a firearm during the commission of a felony Improper Exhibition of a Dangerous Weapon Child Abuse without great bodily harm
Director Carla Quann (Volusia Sheriff's Office Family Resources) was notified of the above incident due to the presence of children. A copy of this report was also sent to the Department of Children and Families for review.
A Risk Protection Order was filed on by Deputy Baba due to the use of firearms in this incident.
was arrested for the above charges and transported to the Volusia County Branch Jail without incident.

Herself, and her two children were inside the kitchen when screamed from the living room to stop talking about politics. Stated a couple of minutes go by and began to get mad at for not knowing where the dog leash was. Then screamed, "Your about to piss me the fuck off." then told to to talk to her grandma like that. Then ran to his room and told to record him with her phone. Then came out of his room holding and pointing a gun at all parties in the residence. Then chased his wife and all parties out of the residence. Then called law enforcement and awaited their arrival.  completed a sworn written statement testifying to the above information. Then completed a Marsy's Law form and chose to keep her information private. Stated she wished to pursue charges on for all applicable crimes to her and her children.
Deputies made contact with who stated the following:  came to so shouse in hopes of having a good night and making pizza with skids. After most of the residents of the get together left, an argument ensued. During the argument, went into his bedroom and grabbed a handgun. He then came out into the kitchen area and pointed the firearm in and staking a video of committing the offense.  was telling all the parties to leave to which they did and called the law enforcement.  completed a sworn written statement testifying to the above information. Then completed a Marsy's Law form and chose to keep her information public.
Deputy Baba then spoke to It should be noted that deputies observed to be extremely intoxicated at the time of incident as well as the time of the interview. During the interview with did say there was a firearm brandished as well as an argument that ensued in the residence. Due to the intoxication level of the quality and quantity of the interview was minimal.

Deputies ordered the parties to retreat away from the residence while the deputies attempted to make contact with and secure the suspect. (D1) exited the residence with his hands raised and he was subsequently taken into custody. Deputies then cleared the residence for any possible suspects.

back into his bedroom and then put the firearm away in his nightstand. Then left the
residence and greeted law enforcement officers at the door.
