On 02/03/2024, at approximately 1500 hours, Deputy Granito responded to Deland in reference to a gunshot detection. Prior to Deputy Granito's arrival, Deland Police Department Officer Mercado arrived on scene and advised a single round had been fired. (See Deland Police Case # DL240000652 for further information.)

Upon arrival, Deputy Granito made contact with (V1), who advised his longtime friend and roommate. (D1), pointed a firearm at him. explained then fired a round towards the ground. stated he and had a verbal argument over rent money earlier in the day after which decided he was going to leave. advised he went into the residence to shower and collect his belongings and brought them stated he was outside having a conversation with outside. (W1) exited the residence and told him to leave the property. when ford pickup truck, remove a black in color firearm, point it at him, then lowered the to his firearm next to his side, pointing it at the ground and discharged a single round stating, "that was your last warning". further explained he was in well founded fear for his life and believed was going to shoot him.

provided a sworn written statement and stated he wished to pursue charges.

Deputy Granito made contact with a who advised he witnessed the incident. Stated and were in a verbal argument when removed a gun from his vehicle and fired a round. Statement coincided with the fact that a firearm was fired; however, denied pointed the firearm at stated did not make any aggressive movements towards with a box cutter.

Due to being unable to read or write, he swore to his verbal statement which was video and audio recorded on BWC.

times to leave, which he did not. stated he was outside when came outside the house with an attitude. advised was seated in a chair outside the residence and had a box cutter in his lap. explained began to get verbal with and stood up at which time the box cutter fell off his lap to the ground. further explained he went to his pickup truck, removed his firearm from the glove box and discharged a single round into the ground while telling to leave the property. denied ever pointing the firearm at stated he placed the firearm back in the glove box of his pickup.

stated Deputy Granito and Sgt. Walsh could retrieve the firearm from his vehicle and voluntarily singed a Volusia Sheriffs Office Consent to Search form. The Consent to Search form Ford pickup bearing FL Tag Deputy Granito took was for photographs of the vehicle and where the firearm was located inside the vehicle. Deputy Granito located an encased 9MM SCCY CPX-2 handgun, (Serial # inside the glove compartment. The firearm was then removed for evidence. Deputy Granito queried the firearm's serial number via FCIC/NCIC, which came back negative, and no record found.

Deputy Granito showed the firearm to which he stated that was the firearm had in his possession and fired during the altercation. Deputy Granito showed the firearm to which he confirmed it was the firearm he used to fire a round into the ground.

Deputy Granito later submitted the firearm and the 7 9mm round into the District 2 Evidence locker. The Consent to Search form was submitted to Records.

Based on the totality of circumstances with the statements and evidence provided, Deputy Granito determined probable cause to charge with Aggravated Assault with a Firearm.

Deputy Granito had Central Communications perform a criminal history check for showed no prior criminal history.
