Stated that her now Ex-Boyfriend bring her son was in the bedroom with their son was in the bedroom with their son was itting on the couch and struck her behind the head with a closed fist hitting her in the neck.  Stood up and raised her arms in a defensive manor questioning for striking her.  Following squestion, threw a closed fist which she blocked. So blocking the punch caused her nail to split on her left hand, which caused it to bleed profusely. Even though blocked the punch it was forceful enough to make contact with her nose leaving visible abrasions. Total walked into the kitchen which gave her the chance to use her work phone at her desk.  Called her mother first who instructed her to call emergency services advised deputies that went into the kitchen and loaded a 9mm handgun and stated "these rounds will plum inside of you".  Continued cursing at she wished to pursue charges. A Victims Right Packet was provided to with the VSO case number.
Deputy Rivera observed to be very upset and scared. There were several moments where had to hold back tears from the fear she was experiencing. Deputy Rivera observed red marks on mose and neck. It is a left hand was covered in blood from a split fingernail consistent with her statement.
