While inquiring about the incident, [REDACTED] came out of the residence.

Deputy Oldham made contact with [REDACTED] who stated he and his daughter were fighting and that she is abusive to him. When asked if he held a firearm to his head, [REDACTED] stated he did because he has had enough.

Based on the statements made to Deputy Oldham from [REDACTED] and [REDACTED] Deputy Oldham determined without help, there is substantial likelihood that without care or treatment [REDACTED] will cause serious bodily harm to himself. [REDACTED] was placed in custody under the Baker Act and transported to Halifax health. His firearm was placed into evidence for safe keeping since it was not able to be secured.
