Deputies created a perimeter around the residence and secured the area. Deputy Rodriguez received information from a family member on scene, was going to exit the residence peacefully. exited the residence peacefully and was secured. Deputies cleared the residence for any other threats or people injured. Deputy Rodriguez located the black handgun in plain view in the master closet on top of the gun safe, which was used in the photograph pointed to head. Deputy Rodriguez informed Deputy Estrada the black handgun had a round inside and the hammer was cocked back ready to be used.
Deputy Estrada would later speak with sister, (W1). confirmed receiving a picture of with a gun to his head.
