I, {full legal name} ALEXANDER ABERLE, in my position as {job title} SHERIFF'S DEPUTY with the {name of law enforcement officer/agency} VOLUSIA SHERIFF'S OFFICE, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

[REDACTED] stated to his child's mother he was going to "off" himself if he couldn't be with her in their relationship.

2. {Name of Witness} [REDACTED] provided the following information based on his/her personal knowledge:

On 10/14/2025 at approximately 0737 hours, deputies were dispatched to [REDACTED] Deland in reference to a disturbance. Dispatch call notes advised a male was sitting behind a vehicle preventing the driver from leaving. Additionally, call notes advised the male tried to open the doors to the vehicle and made suicidal statements about him wanting to "off" himself if he couldn't continue the relationship with the reporting party.

Deputy Aberle and Deputy Gardner arrived on scene and immediately contacted ██████████ (V1) who was at the driver's door trying to speak to the driver and reporting party, ██████████ (R1). Deputies secured ██████████ and separated him from the vehicle.

Deputy Gardner contacted ██████████ who stated prior to dropping off her two children, ██████████ a minor, (O1) and ██████████ a minor, (O2), at school, she went to ██████████ residence to pick up ██████████ backpack that was left there from yesterday. ██████████ tried to talk to ██████████ but she did not want to talk. While walking back to her car, ██████████ ran to the back of her car and sat down so she couldn't move the vehicle. Eventually, ██████████ stood on the driver's side of the vehicle trying to open the door and was banging his head on the window. ██████████ said he would "Off" himself with a gun.

██████████ provided a sworn statement documenting her account of the incident. Her statements were captured on Deputy Gardner's Body Worn Camera (BWC).

Deputy Aberle contacted ██████████, who was upset and angry. ██████████ initially did not want to provide his name and said we knew his name and could look it up. Deputy Aberle read ██████████ his Constitutional Rights from his agency issued Miranda Warning card. ██████████ understood and stated the following:

██████████ came to the house and then left after he tried to talk to her. ██████████ admitted to sitting at the back of the vehicle and said all he wanted to do was speak to ██████████ and ██████████ denied making any statements of harming himself.

Based on the totality of circumstances, Deputy Aberle determined ██████████ was actively going through a mental health crisis and was in need of mental health intervention, or he would likely cause harm to himself.

██████████ denied access to his residence to take possession of any firearms or weapons. Additionally, he declined to specify anything about the weapons he owns or has access to.

Deputy Aberle took ██████████ into protective custody under a Baker Act and transported him to SMA's Chet Bell Crisis Center, Daytona Beach for further evaluation.
