I, {full legal name} Deputy Jacob Adle, in my position as {job title} Deputy Sheriff with the {name of law enforcement officer/agency} Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

- {Name of Respondent} \_\_\_\_\_ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

While making comments in Henry County, Georgia, \_\_\_\_\_ caused a response from the local agency. \_\_\_\_\_ then fled from law enforcement in her vehicle, but at a certain point came to a stop, exited the vehicle and held her firearm to her head. \_\_\_\_\_ made a social media post indicating a "goodbye" and telling her family to take care of one another. \_\_\_\_\_ also disposed of the firearm in an unknown waterway in her travels back to Florida.

On Thursday, 10/16/2025, at approximately 1854 hours, Deputy Adle was dispatched to a BOLO (be on the lookout) for [REDACTED] (V1) operating a black 2022 Ford F-150 Pickup Truck bearing FL Tag [REDACTED]. The BOLO was issued for a well-being check on [REDACTED] concerning suicidal acts (placing a firearm to [REDACTED] head) in Henry County, Georgia, and concerning a Facebook post she made. Deputies were initially dispatched to the area of exit 278 Southbound I-95, Ormond Beach, as the vehicle was observed on technology entering Volusia County.

At approximately 1913 hours, deputies were informed PINGS were being conducted on [REDACTED] phone and showed her in the area of Pine Woods Drive and W SR 40, Ormond Beach. More information was learned of a nephew, [REDACTED] (O1), of [REDACTED] who resided at [REDACTED] Ormond Beach. Deputies learned that [REDACTED] was on scene at [REDACTED] at approximately 1937 hours from [REDACTED]. It was established [REDACTED] was no longer armed, with family, and willing to speak with deputies.

Deputies made contact with [REDACTED] inside the residence at approximately 1942 hours, and [REDACTED] provided the following verbal account to deputies:

[REDACTED] was in Georgia with her brother and her brother's new girlfriend. [REDACTED] added her sister-in-law passed away about three (3) years ago and she had not had time to grieve the passing. While with [REDACTED] brother, [REDACTED] sister-in-law's ashes were inside the residence and caused [REDACTED] emotional distress triggering her PTSD from a full and difficult law enforcement career. It is unclear what [REDACTED] spoke to her brother about, but [REDACTED] left the residence and caused a local law enforcement response to the area to locate [REDACTED] and check her well-being. [REDACTED] was located by Henry County deputies; a traffic stop was attempted, but [REDACTED] fled from deputies. During this incident, [REDACTED] eventually did stop for deputies. [REDACTED] exited her vehicle armed with her old department issued Glock 40, pointed it to her head, and told deputies to leave her alone while she returns home. While on [REDACTED] travels home she stopped at an unknown overpass and discarded her firearm into a waterway. [REDACTED] confirmed the firearm would not be able to be located by anyone to include children. [REDACTED] advised she does not have any further access to firearms at this time.

With the information gathered from Henry County and from █████ account it was determined, if left alone there is substantial likelihood that without care or treatment █████ will cause serious bodily harm to herself.

█████ was placed into protective custody under the Baker Act Statue and transported to Stewart-Machman-Act (SMA) Health Care for further treatment.




