On 11/15/2025 at approximately 2200 hours, [REDACTED] and her boyfriend [REDACTED] went to the restaurant Mama Foo Foo in Daytona Beach for some drinks to celebrate her birthday. While at the restaurant [REDACTED] had a couple beers and [REDACTED] shared a glass of wine with her friends who were in attendance. [REDACTED] stated after a couple beers, [REDACTED] began getting more and more irritated which led to an argument in the restaurant. The argument caused [REDACTED] to “storm out” out of the restaurant into the parking lot. By this time, it was late and they figured it was time to go home anyways. [REDACTED] and [REDACTED] got into the back seat of their friend’s car to be driven back to their vehicle. [REDACTED] advised while driving back to their friend’s house, [REDACTED] continued escalating the argument. [REDACTED] stated eventually [REDACTED] got so angry he reached across his body with his left hand and grabbed her by the neck causing difficulty breathing and banged her head against the glass. The driver of the vehicle slammed on the brakes and yelled at [REDACTED] to stop and he did. They eventually arrived at the friend’s house and [REDACTED] went inside by herself and [REDACTED] was eventually picked up by his child from the residence. [REDACTED] stated she does not wish to press charges.

After being picked up by his child, [REDACTED] continued to make suicidal statements such as, “you’ll be better without me”, “you can come to my funeral next”, “everything will be okay”. [REDACTED] was also simultaneously texting his friend in Texas that he doesn’t want to live anymore. The friend in Texas is the original caller who made VSO aware of an incident occurring. [REDACTED] informed Deputies [REDACTED] does have multiple weapons, but they are at his mother’s house in DeLand due to safety concerns except for a Glock Pistol.

[REDACTED] has shown an extreme desire to harm himself by any means necessary. [REDACTED] is diagnosed with PTSD and is currently in treatment for it at the VA. As a result of this incident [REDACTED] was subsequently arrested for DV Battery by strangulation.
