On 04/12/2025, Deputy Emanuel responded to Wes Crile Park for a male threatening someone with a firearm. Upon arrival, Deputy Emanuel and Sgt. King observed a male matching the description of the suspect walking in the parking lot. The suspect identified later as (D1), was secured into handcuffs immediately due to the accusations against him.
immediately spontaneously uttered in the presence of Sgt King, "its not a real gun it's a BB Gun". was placed into a patrol car and read his Miranda rights. Post Miranda, informed Deputy Emanuel this incident is a result of testosterone levels being high and not being able to control his emotions. admitted he did retrieve the gun for the purpose because he felt threatened. also asked multiple times if he could apologize to the victim and his family for his actions.
Deputy Emanuel then spoke with the victim (V1) who advised the following in a sworn written statement:
On 04/12/2025, he was playing basketball at Wes Crile park with his friends inside of the basketball court gym. While playing, a male later identified to him as began playing very aggressive. Stated before the game even started that he is a very aggressive player and everyone is going to have to deal with it. At the conclusion of a game, and got into a verbal altercation that almost turned physical. The abruptly leaves the gym and returns with what looks like a firearm in his right pocket. Then approaches brandishes his firearm and says what are you going to do now, insinuating he would use the firearm in his pocket if were to fight him. Stated at this time he was in fear of his life and retreated from the situation. It is family was on scene at this time and separated the two even more. The began shouting threats at other family members but by this time the firearm was no longer in his immediate possession.
Deputy Emanuel spoke with multiple witnesses to include, juvenile (W1), juvenile (W2), juvenile (W3) at the scene of this incident. All witnesses gave identical accounts of what happened that directly coincided with the statements given by the victim and the post Miranda admission of guilt told by
