It is to be noted that has been diagnosed with Autism.

Deputy Baba arrived at the above address and made contact with who stated that he wanted to harm himself due to issues with his girlfriend and people not understanding him. The quality and the quantity of the conversation with minimal due to autism.

Based on the above stated information, Deputy Baba determined there was a significant likelihood that without care or treatment, **see and cause** serious bodily harm to themselves, as evident by recent behavior. Deputy Baba further determined **see and set and set**

During **Sector** time in custody, he made statements that he was going to go back to the school (University High School) and kill everyone that told on him. Deputy Baba then made contact with **Sector** (O1) who stated there are firearms in the home but they are locked up and **Sector** does not know his parents own firearms. Due to the above information and statements made by **Sector** a Risk Protection Order (RPO) was submitted by Deputy Baba.

 - 3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
 - 4. Abide by any other lawful relief the Court may order.

Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.

A **RISK PROTECTION ORDER** in this matter requiring Respondent to:
