SECTION V. RISK PROTECTION ORDERS
For the foregoing reasons, petitioner requests the Court to enter:
X A TEMPORARY EX PARTE RISK PROTECTION ORDER in this matter requiring Respondent to:
<ol> <li>Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the {name of law enforcement agency}; Volusia Sheriff's Office</li> </ol>
2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect;
3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
4. Abide by any other lawful relief the Court may order.
Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.
A RISK PROTECTION ORDER in this matter requiring Respondent to:

- 1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the *{name of law enforcement agency}*;
- 2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect;

Petitioner requests the Risk Protection Order to remain in effect for a period the Court deems appropriate, up to and including but not exceeding 12 months.

Deputy Estep was then alerted by the Deland Police Department they had made contact with and placed him into protective custody. The Deland police officers advised originally denied all allegations. However, after being confronted with the statements provided by and and advised that he told he was going to kill himself, but he didn't mean it. Only wanted a reaction out of
It should be noted prior to being placed into protective custody, gave the Deland Police officers permission to search his personal vehicle. Where a 12-gauge shotgun and 34 12-gauge shotgun shells were discovered.
Deputy Estep then responded to the Deland Police officers' location.
Based on the totality of the circumstances, Deputy Estep determined there is a substantial likelihood that without care or treatment, would likely cause serious bodily harm to himself in the near future, as evidenced by his recent behavior. Therefore, was placed into protective custody under the Baker Act guidelines.
Deputy Estep then transported to SMA Daytona Beach for involuntary evaluation. Due to the statements made, a Temporary Risk Protection Order was filed against voluntarily surrendered his firearm on scene to Deland Police officers. Deputy Estep completed a TRPO in reference to this incident.
