On 08/08/2025, at approximately 1023 hours, Deputy Bourbour was dispatched to _____ OB, FL, in reference to a suicidal person. Prior to arrival, Central Dispatch advised _____ (V1) was on the phone with a nurse who works for Veterans Affairs (VA). Monica advised a nurse was on the phone with _____ who stated he was feeling suicidal and had a plan to harm himself. _____ also told the nurse he had weapons, and they were loaded, _____ also advised he told his friends "Goodbye." Deputies arrived on scene and established a perimeter around _____ residence.

Once Deputies were in place, attempts to reach _____ on his phone were met with negative results. Deputies formed a receiving team while attempts to contact _____ were made. _____ was still on the phone with Monica who was advised by Central Dispatch to have _____ step outside. _____ eventually came outside unarmed and was contacted by deputies. _____ advised he was going through a lot and needed to go to the hospital. Deputies helped secure _____ residence. It should be noted; there were no weapons seen while in _____ residence or in his possession.

Deputy Bourbour determined without proper care or treatment; there was sufficient likelihood _____ would cause harm to himself due to his mental status. _____ was taken into protective custody under the Baker Act, and transported to Halifax Hospital, located in Daytona Beach, without incident. A risk protection order (RPO) was also completed due to the accusations of being suicidal and having loaded firearms in his house.

2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect;
3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
4. Abide by any other lawful relief the Court may order.

Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.

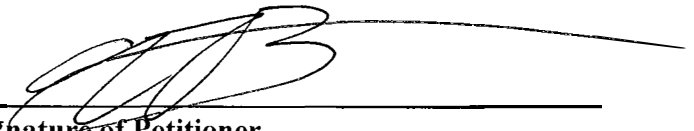
 X **A RISK PROTECTION ORDER** in this matter requiring Respondent to:
