On 08/08/2025, at approximately 1023 hours, Deputy Bourbour was dispatched to OB, FL, in reference to a suicidal person. Prior to arrival, Central Dispatch advised (V1) was on the phone with a nurse who works for Veterans Affairs (VA). Monica advised a nurse was on the phone with who stated he was feeling suicidal and had a plan to harm himself. It also also told the nurse he had weapons, and they were loaded, also advised he told his friends "Goodbye." Deputies arrived on scene and established a perimeter around residence.
Once Deputies were in place, attempts to reach on his phone were met with negative results. Deputies formed a receiving team while attempts to contact were made. was still on the phone with Monica who was advised by Central Dispatch to have step outside. eventually came outside unarmed and was contacted by deputies. advised he was going through a lot and needed to go to the hospital. Deputies helped secure residence. I should be noted; there were no weapons seen while in residence or in his possession.
Deputy Bourbour determined without proper care or treatment; there was sufficient likelihood would cause harm to himself due to his mental status. was taken into protective custody under the Baker Act, and transported to Halifax Hospital, located in Daytona Beach, without incident. A risk protection order (RPO) was also completed due to the accusations of being suicidal and having loaded firearms in his house.

 - 3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
 - 4. Abide by any other lawful relief the Court may order.

Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.

X A RISK PROTECTION ORDER in this matter requiring Respondent to:

- 1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the {name of law enforcement agency}; **VOLUSIA SHERIFFS OFFICE**
