On 12/14/2025, at approximately 0126 hours, Deputy Williams was dispatched to a suicidal person located at ██████████ in Deland. Dispatch received a call advising that ██████████ (V1) was suicidal at the aforementioned address and was armed with a firearm. The reporting parties were later identified as ██████████ daughter ██████████ (O1) and ██████████ (O2) who was ██████████ brother. ██████████ told deputies that ██████████ was admitted to the hospital on 12/13/2024 and was released from the hospital on 12/14/2025. ██████████ was admitted due to being heavily intoxicated and having a substance abuse issue. ██████████ believed that ██████████ was highly intoxicated and suffering from depression.

██████████ was on the phone with ██████████ while also being on the phone with ██████████ which allowed ██████████ to relay real time information on ██████████ whereabouts. ██████████ advised Sergeant McIntosh that ██████████ was walking through the trailer park with a firearm and was planning on shooting himself in the head. ██████████ had also received the following suicidal text message from ██████████ earlier in the evening. "I don't think I'm going to make it through the night, I love you, my always been strong, my daughter love you always."

Upon receiving information about ██████████ walking through a crowded RV park with a firearm, Deputy Williams began walking the RV park in an attempt to locate ██████████ While deputies were searching the park ██████████ went back to his trailer and secured his firearm inside. ██████████ was then able to talk ██████████ out of his trailer via phone call where Deputies were able to make contact with ██████████ ██████████ was secured and placed in protective custody under the Baker Act.

██████████ was transported to 704 in Daytona for further treatment and care.

An RPO was completed to prevent further incidents.
