I, {full legal name} Deputy Jacob Adle, in my position as {job title} Deputy Sheriff with the {name of law enforcement officer/agency} Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

██████████ reported he did not want to hurt anyone else but wanted to point his firearm at law enforcement to commit suicide by cop. ██████████ then uttered he wanted law enforcement to shoot him (██████████) and been having issues since his birthday, two days prior.

2. {Name of Witness} ██████████ provided the following information based on his/her personal knowledge:

██████████ noted ██████████ always struggles with his (██████████) mental health around ██████████ birthday. Prior to law enforcement being contacted, ██████████ held his firearm to his head and threaten to shoot himself. ██████████ was able to get the firearm away from ██████████ and this is when ██████████ exited the residence to contact law enforcement. ██████████ firearm is Glock 33 Pistol.

On Friday, 12/19/2025, at approximately 1831 hours, Deputy Adle responded to ██████████ ██████████, Ormond Beach, in reference to a suicidal person. While en route to the residence, the reporting party, ██████████ (V1), was calling in on his own behalf. ██████████ reported the following to the call taker the following information:

██████████ reported he did not want to hurt anyone else but wanted to point his firearm at law enforcement to commit suicide by cop. ██████████ does own a firearm; however, he left the firearm secured inside the residence and he was outside in the driveway. ██████████ was outside of the residence next to his vehicle along with his mother, ██████████ (O1).

Once Deputy Adle arrived on scene, ██████████ immediately apologized for wasting deputies time and causing law enforcement to respond to his residence. ██████████ then uttered he wanted law enforcement to shoot him (██████████ and been having issues since his birthday, two days prior. ██████████ was asked why he (██████████ was having thoughts of self-harm, but ██████████ did not elaborate on why. ██████████ only spoke on how he has been sober from alcohol for approximately three (3) months but has been consuming alcoholic beverages since his birthday (12/17/2025).

With ██████████ wants of suicide from the hands of law enforcement and excessive alcoholic beverages consumption, ██████████ was placed in custody under the Baker Act statute. This was based on ██████████ self-harm thoughts and the inability to make a conscious decision to seek help himself besides calling law enforcement.

With ██████████ on scene, she provided a few more details on the incident; however, nothing greatly specific. ██████████ noted ██████████ always struggles with his (██████████ mental health around ██████████ birthday. Prior to law enforcement being contacted, ██████████ held his firearm to his head and threaten to shoot himself. ██████████ was able to get the firearm away from ██████████ and this is when ██████████ exited the residence to contact law enforcement. ██████████ firearm is Glock 33 Pistol; however, ██████████ did not allow deputies to enter the residence to retrieve the firearm for safe keeping.

With ██████████ severely intoxicated, Deputy Adle was unable to explain to ██████████ a Risk Protection Order would be completed and filed with the courts. Deputy Adle did generate a Volusia Sheriff's Office Risk Protection Order Notification Form, which was presented to ██████████ to share with ██████████ at a later date.

3. Affiant is is not aware of any existing protection order governing the respondent under any applicable statute.


