On 01/17/2026, at approximately 1408 hours, Deputy Rubin responded to _____ Deland, In reference to a suicidal person.

Prior to arrival, Central dispatch advised Deputies _____ (VI) was in the back yard with his parents in a verbal argument while holding a firearm and stating he was “just going to kill myself”.

Upon arrival, Deputies met with _____ (O1) who advised him and his son _____ were in a verbal argument which then escalated to _____ grabbing a firearm from in his vehicle. _____ advised _____ never pointed the firearm at, and never made any threats towards, anyone on scene. _____ explained while _____ was holding the firearm he stated he was going to kill himself. _____ was then able to remove the firearm from _____ then immediately took off running through the neighbor’s property. _____ completed a sworn written statement detailing the issue.

Shortly later Deputies were able to locate _____ in the 1700 blk of Trinidad St, Deland. _____ was running through the woods while on the phone with his mother. Deputies were able to pinpoint a general area of _____s whereabouts through the dialogue of the phone call. Deputies along with Deland Police Department secured _____. _____ explained that he has been severely depressed in the past couple months due to losing a job and not being able to find a new one. _____ expressed he never wanted to hurt anyone nor himself and thought since the police were called he was going to go to jail so he decided to run and hide.

Based on the above stated information, Deputy Rubin determined there was a significant likelihood that without care or treatment, _____ could cause serious bodily harm to himself, as evident by recent behavior. Deputy Rubin further determined _____ was unable to determine for himself whether psychological examination or medical care was necessary. Deputy Rubin placed _____ into protective custody under the provisions of the Baker Act. _____ was transported to Stewart Marchman in Daytona.
