On 01/19/2026, at approximately 1233 hours, Deputy Moorhouse responded to \_\_\_\_\_, Ormond Beach, in reference to a suicidal person. After arriving on scene, Deputy Moorhouse made contact with \_\_\_\_\_ (W1) who advised the following:

\_\_\_\_\_ reported her son, \_\_\_\_\_ (V1), had been upset as she had asked him to move out. \_\_\_\_\_ stated her son had been staying with her for approximately 7 years, after \_\_\_\_\_ left the Army. \_\_\_\_\_ advised she asked \_\_\_\_\_ if he wanted help packing to which he responded, no it doesn't matter. \_\_\_\_\_ stated he had made similar statements in the month prior, including a statement that he would blow his brains out. \_\_\_\_\_ advised based on that previous comment she asked \_\_\_\_\_ if he was feeling suicidal, to which he replied yes. \_\_\_\_\_ stated she then contacted the VA, who directed her to call law enforcement. \_\_\_\_\_ completed a sworn written statement.

Deputies additionally spoke with \_\_\_\_\_ (W2), who advised he also witnessed the conversation between \_\_\_\_\_ and \_\_\_\_\_ and provided the same information \_\_\_\_\_ did. \_\_\_\_\_ completed a sworn written statement.

Deputies made contact with \_\_\_\_\_ through his bedroom door. \_\_\_\_\_ initially refused to speak with deputies; however, he eventually did exit his bedroom. \_\_\_\_\_ was visibly in distress with tears well up in his eyes. \_\_\_\_\_ room was trashed with boxes and clothes covering the floor.
