On 02/27/2026, Deputy Victor responded to _____, Deltona, in reference to a suicidal person.

Prior to arriving on scene, deputies received information from _____ (W1) that _____ (V1) told her he was going to take pills and then shoot himself. _____ also stated she observed _____ take multiple Xanax pills throughout the day in an attempt to harm himself. _____ further advised that _____ made comments indicating he intended to commit "suicide by cop." _____ also informed deputies that _____ had a firearm in his vehicle.

Upon arrival, deputies called _____ out of his residence and placed him into protective custody based on the statements he made to _____ and his ingestion of an excessive amount of medication. It should be noted that _____ stated multiple times, in the presence of Deputy Victor, that he was suicidal and upset with law enforcement because he was "on his way out."

Due to _____'s explicit mention of using a firearm to harm himself and others, Deputy Victor completed and submitted a Risk Protection Order (RPO).

_____ was transported to AdventHealth Fish Memorial in Orange City and placed under a Baker Act.
