"No snappy come back now bitch huh wonder why?! Fucking whore."
"He won't let him pull your hair cause it'll come right off of your head right bitch you don't like
to swim in the ocean because you're afraid of the sharks will be very afraid of this shark you
fucking whore."
" if you're in possession of my husband's truck, I'm gonna have you
arrested for felony trespassing I'm gonna have you arrested for felony theft. I'm gonna have you
arrested and thrown under the jail bitch run but nu can't hide."
"Keep reading the messages I can see you. Run run run you fucking hoe"
"U2 started this battle! U2 have fucked over the wrong one again"
"Are we having fun yet When are you coming, dear? Yeah I got that little gun you gave me.
I'm not sure whether I wanna shoot him in the hat or just me."
"Of course it would be better if I didn't kill him I was just shooting him in the leg. I'm not sure
cause his name is His birthday is take him out."
"Oh no, yeah he's had that the out there in the country out there in the country of the country
"So you got kind of court cleared out for me thank you"
"Yeah, that rack in the master bedroom closet was broken. I think he fixed it though."
It should be noted was having this entire conversation with herself and at no point did
respond to the text messages. has been baker acted a few times prior and he
believes in addition to her opioid and alcohol abuse she may be showing some signs of early
onset dementia which runs in her family.

have law enforcement involved but due to threatening to use a firearm not only to hurt him but herself he believes he is unable to get the help she truly needs without law enforcement assistance.
Deputy Crofutt made contact with at at Daytona Beach Shores who appeared to be erratic and possibly under the influence and/or in the middle of psychotic episode. admitted to Deputy Crofutt sending the aformentioned text messages and stated "I don't want to kill him, I am just very angry, and just want to maim him which is why I said the leg".
Due to admission of sending the aforementioned text messages, her erratic and unexplained behavior, Deputy Crofutt determined is not only a danger to herself but others as evident by her recent behavior. Deputy Crofutt placed into protective custody under a baker act and later transported to Halifax Health Daytona Beach for further medical and psychiatric care.
It should be noted admitted to owning a firearm but stated she was unaware where she put the gun. Deputy Crofutt could not locate the firearm at the time of this report. Deputy Crofutt completed a risk protection order as well due to the threats mentioning a firearm.

#### SECTION V. RISK PROTECTION ORDERS

For the foregoing reasons, petitioner requests the Court to enter:

# X A TEMPORARY EX PARTE RISK PROTECTION ORDER in this matter requiring Respondent to:

- 1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the *{name of law enforcement agency}*; VOLUSIA SHERIFFS OFFICE
- 2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect:
- 3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
- 4. Abide by any other lawful relief the Court may order.

Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.

### X A RISK PROTECTION ORDER in this matter requiring Respondent to:

- 1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the {name of law enforcement agency}; Volusia Sheriff's Office
- 2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect:
- 3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
- 4. Abide by any other lawful relief the Court may order.

Petitioner requests the Risk Protection Order to remain in effect for a period the Court deems appropriate, up to and including but not exceeding 12 months.
