Upon arrival, Deputy Gardner observed [REDACTED] open the front outside door with a 12-gage shotgun in hand. While Deputy Gardner was getting into a safe position, he observed [REDACTED] placing the shotgun outside of the front door against the wall where he was no longer armed. By this time, additional deputies arrived on scene and began to give loud verbal commands to [REDACTED]. Note, [REDACTED] was within the residence, but at the front door sitting in his wheelchair.

Deputy Gardner, who was on the northwest side of the residence, began gathering a rapport with [REDACTED]. While deputies were communicating with [REDACTED], he complied and held his hands up and outside of the front door. Deputies then moved forward and secure [REDACTED] without incident.

Once [REDACTED] was secured away from the residence and the residence was cleared of any further threats, Deputy Shaheen made contact with [REDACTED] (RP) who stated the following:

While she was talking to [REDACTED] inside of the residence, she mentioned how they were looking into a nursing home for [REDACTED] to live in. While talking about a nursing home, [REDACTED] became upset and stated, "So you're going to put me in a nursing home?" which [REDACTED] agreed, replying that there was no other choice as his Parkinson's disease was not getting better. [REDACTED] then said, "Well I don't have anything to live for, do I?" [REDACTED] then said he needed to use the restroom and walked down the hallway. [REDACTED] then heard [REDACTED] shout her name, which [REDACTED] responded and walked to the bedroom where she observed [REDACTED] with his shotgun barrel pointed upwards under his chin, all while attempting to pull the trigger. [REDACTED] became fearful and exited the bedroom and called 911 for help.

According to [REDACTED], [REDACTED] did this exact thing about 1 year ago. [REDACTED] stated [REDACTED] does not have any mental illness but does have health problems and that his memory is not like it use to be.

[REDACTED] provided Deputy Shaheen with a sworn written statement about the incident.

Deputy Gardner transported [REDACTED] to Halifax Hospital, Daytona Beach for further treatment.

For the foregoing reasons, petitioner requests the Court to enter:

____ A **TEMPORARY EX PARTE RISK PROTECTION ORDER** in this matter requiring Respondent to:

1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the *{name of law enforcement agency}*;

2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect;
3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and
4. Abide by any other lawful relief the Court may order.

Petitioner further requests this Court to schedule a Hearing for a Risk Protection Order to be held within 14 days.

X A **RISK PROTECTION ORDER** in this matter requiring Respondent to:

1. Immediately surrender all firearms and ammunition in his or her custody, control, or possession and any license to carry a concealed weapon or firearm to the *{name of law enforcement agency}*;

2. Not have in his/her custody, control, or possession any firearm or ammunition while this order is in effect;
3. Not purchase, possess, receive, or attempt to purchase or receive, a firearm or ammunition while this order is in effect; and

Petitioner requests the Risk Protection Order to remain in effect for a period the Court deems appropriate, up to and including but not exceeding 12 months.
